Entry Day

Entries must be hand-delivered to the exhibition site at 220 First Street, Eureka between 11am and 3pm on Saturday, September 19, 2009.

Eligibility and Entry Fees

Neither Redwood Art Association nor Eureka Photoshop Users Group membership is required. Entrants must be residents of Humboldt County. Entry fees are \$15 per entry with a maximum of 3 entries per person. Make checks payable to the RAA.

Landscape, people, abstract, floral, digital creation, and other

Awards and Arts Alive! Reception

A Private Preview and Reception for entrants and guests will be held from 5 - 6 p.m. before Arts Alive!, Saturday, October 3. Over \$2,400 in awards including Adobe CS4 Software "Best of Show" and \$100 for each "Best of Category" will be presented at 5:30 p.m.

Exhibition Judge

Crista Dix, owner and director of the Wallspace Gallery in Seattle (www.wallspaceattle.com), will judge this Exhibition. Starting in this creative field as a photographer, collector and lover of the visual image, Crista decided to put down her camera and utilize her years of business management to help promote photographers and photography. With a background in science, business and creative arts, she has created a gallery space that celebrates artists' vision. She has been a member of numerous panels and discussions, juried creative competitions and has participated in major portfolio reviews across the country.

Pick Up Day

Exhibited work must remain on display for the entire show through Friday, October 16, 2009, and must be picked up on **Saturday, October 17, from 11am to 3pm.** Please present artist's receipt when claiming work. If you cannot come on that day, designate someone else to come with your receipt or a note from you and pick up your work. Artwork cannot be held beyond October 17.

Presentation Specifications

All work must be suitably prepared for exhibition. **Must be ready for hanging with strong hanging wire (or professionally installed picture cord) securely attached to a strong frame. No sawtooth hangers.** Photographs should be protected by glass or Plexiglas and must be framed—no unframes with glass or glass and clips but not protected with a surrounding frame. **NOTE: Frame dimensions can be no larger than 36 by 48".** No diptychs, triptychs or other separate multi-paneled works can be accepted.

Restrictions

Entries must be original, unassisted work of the artist and not previously exhibited in any RAA exhibit. RAA reserves the right to refuse work on the basis of content unsuitable for the exhibition. Entries must not violate copyright laws.

Sales

Sales are encouraged. The RAA will collect no commission, but will notify the artist, who must carry out the sale. Work not for sale should be clearly labeled NFS on the entry forms. Sold work must remain on display in the gallery until the end of the exhibition.

Insurance/Liability

Work entered in the exhibit will be insured as provided for in the insurance policy held by the Redwood Art Association while on the exhibition premises, from September 19 to October 17, 2009. The artist must declare the insurance value of the work, not in excess of the sale value. **If requested, proof of insurance value in the form of a licensed appraisal or documented sales history must be provided.**

Signature

Your signature on the entry form indicates understanding of and compliance with all the rules of this exhibition.

Waiver of Responsibility

I am submitting the following entries to the Humboldt Photography Exhibition presented by the Redwood Art Association in collaboration with the Eureka Photoshop Users Group.

I understand that the RAA and EPUG assumes no responsibility or liability for works damaged, broken or lost while on the exhibition premises, beyond the insurance coverage provided for in the insurance policy held by the Redwood Art Association. I also understand that the RAA and EPUG are not liable for wear and tear that may occur by handling during entry, judging, spotting, hanging and take down.

The RAA and EPUG will not assume any responsibility for damage to works while in transit to or from the exhibition site, or for pieces left beyond the specified pick up date. See entry rules for more information regarding the beginning and ending of dates of coverage, values, etc.
